3) PRESENTATIONS

a) Organizational Update – Andy Anuzis

In previous years we have had up to 50 vacancies, currently we only have 5 vacancies. Vacancies breakdown by grades: Kindergarten – fully staffed, First grade – 2 vacancies, Second grade – 1 vacancy, Third grade and Fourth grade – no vacancies, Fifth grade – 1 vacancy, Sixth and Seventh grade – 1 vacancy. We have attained a grant, if we can find a certified music teacher their salary would be covered. Our team will find quality people to fill these positions.

b) Academic Update – Maggie Durant

We focused on early reading this year. We have experienced growth this year in Reading and Math. When comparing to Spring to Spring testing results we see a 2% increase in Reading and a 6% increase in Math. We focused on phonics in grades K-3. We invested in paperback books for the younger students, we found that when they have something tangible to hold they are more likely to enjoy reading and want to read more often. We used seasoned teachers to model teaching for the more inexperienced teachers on staff.

c) Enrollment Update - Dustin Quarrella

We have started geo-focused Instagram and Facebook ads as of 2 months ago. Dawn to Dusk and clubs offered by schools are a big interest to potential new families. We are planning on inviting new families to summer events to keep them interested in Cornerstone schools. We have a new team member in the Enrollment Department that is conducting calls and texts in the evenings and weekends. At Jefferson-Douglass Academy 84% of families want to stay. This time last year the reenrollment rate was at 70%. New applications for Jefferson-Douglass Academy are at 164 so far, which is the Third highest school district wide.

We feel like we have a crystal-clear picture of our financials. We started last year with \$700,000

in our budget. Due to the ESSER funds being withheld we will be in a \$500,000 fund deficit. Our Deficit Elimination Plan includes CSA loaning us \$167,000 each year divided into monthly payments. We will gain \$200,000 from newly enrolled students, we are basing this number on conservative enrollment numbers, this number will most likely be higher. \$685,000 will be cut from expenditures, we have already identified \$500,000 of that. We have also cut the number of administrators per building.

The Budget hearing was rescheduled for June 27, 2024 at 8:00 a.m. Notices will be reposted.

There is a new Student Success Center at Grand Valley State University. It is currently under construction and is expected to open this Fall.

A record number of charter students have entered Grand Valley State University this year through visits. Also, a record number of Charter High school seniors will participate in College prep this year.

Starting next month, the email that Board members receive from McDaniel will contain more information and have a new look.

Legislative Updates: There is a proposal at the State, Senate, and Executive level to increase per pupil funding. At the Governor's office they are proposing 98.49 per pupil. At the House level there are proposing 98.25 per pupil, and at the Senate they are proposing 99.10 per pupil.

Funding for charter cyber schools has decreased.

There is a bill on the table that will require schools to post staff salaries on their website if passed.

Promotional Materials bill if passed will require all charter schools to include their authorizer and management company's name and logo on their website, enrollment documents, and promotional materials.
